### Wants Alimony Returned.

A dispatch sent out from Omaha Saturday says:—Charging that the alimony settled on his former wife when she secured her divorce last February was obtained by misrepresentation and fraud in conspiracy with W. R. McKeen, whom she afterwards married, C. W. Hull has brought suit in district court against his former wife to compel her to pay back to him the \$31,000 alimony she has already collected and to restrain her from collecting the remainder of the \$91,000 he agreed to pay her.

Mr. Hull alleges in his petition that for two years previous to the divorce, his wife and McKeen conspired to get the divorce and alimony for her and marry. He says he was forced to settle on the terms Mrs. Hull demanded, because she threatened to make public her petition which contained statements about his private business that he could not afford to have made public at the time.

The case was settled out of court and only a part of Mrs. Hull's petition became public.

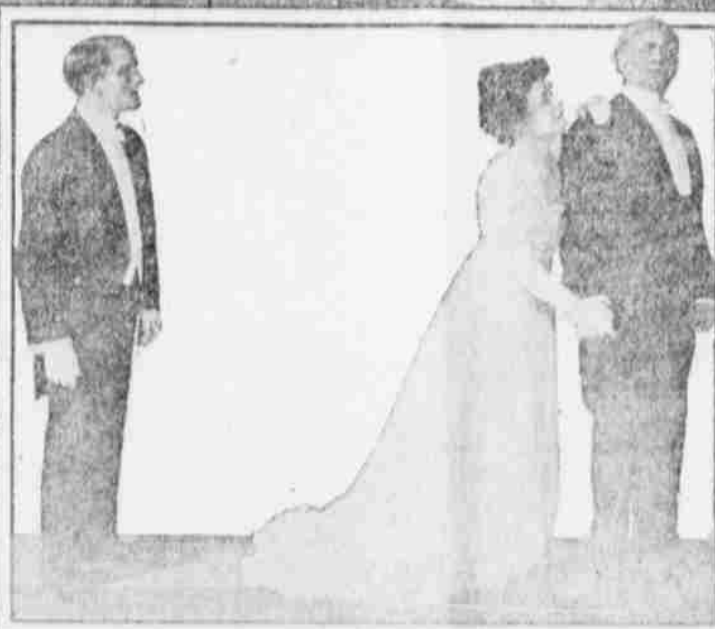
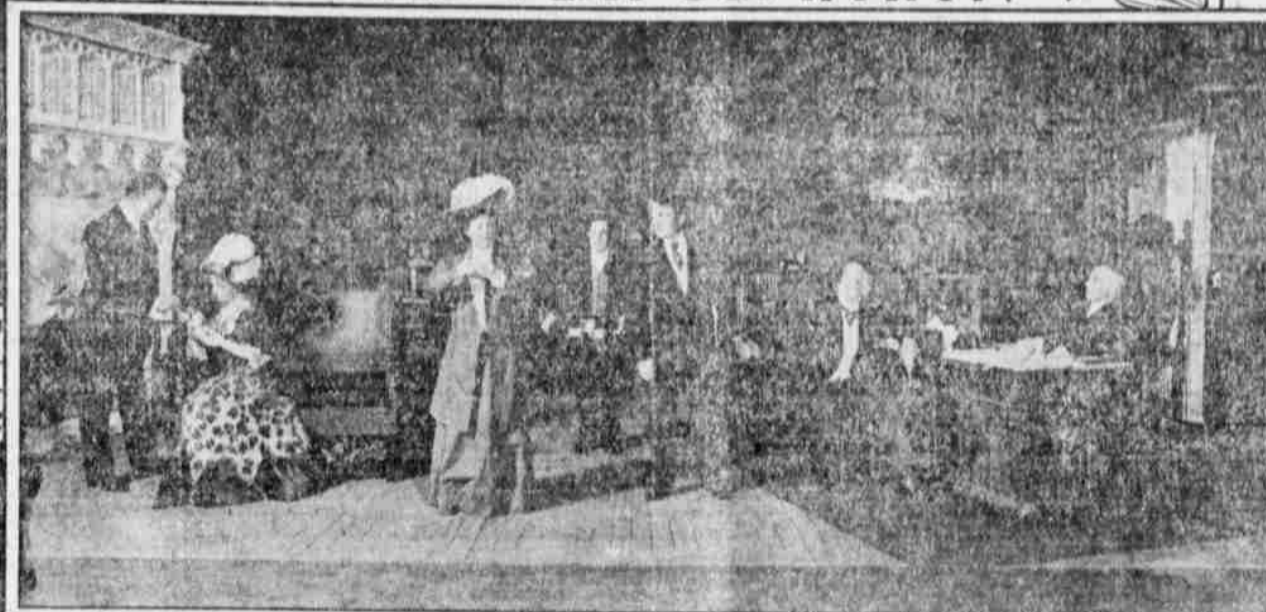
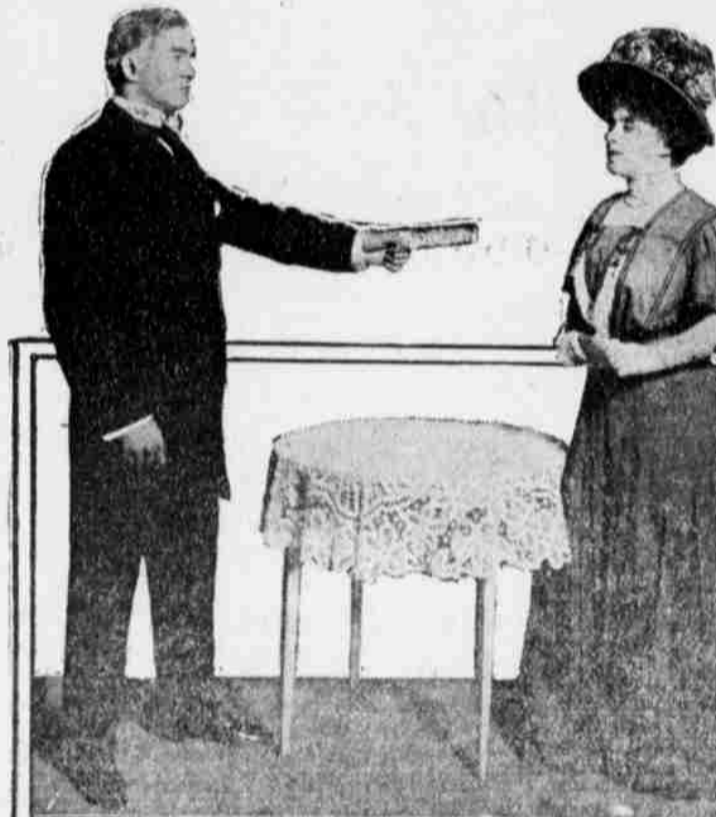
### Socialist Lyceum Course.
