Eight Tooley tailors, governors of states, met Chicago, adopted resolutions, sent out telegrams and writ a letter to the Colonel, from whom we may soon hear—doubtless to the contrary.

Eliminating the sound and fury, the fuss and fustian, let us see how the score stands. Delegates elected to date 21. Taft, 21; Roosevelt, 0; LaFollette, 0; Cummins, 0; Democrats, 0. New York City republican committee endorsed Taft 478 to 17.

Chicago city convention. Taft; 589; Roosevelt, 180.

St Louis city committee endorsed Taft.

Second Iowa Congressional district committee unanimously endorsed Taft. This is Cummins' own state.

The Colorado state central committee overwhelmingly endorsed Taft.

The Illinois Lincoln League endorsed Taft.

The Utah state central committee has declared for Taft.

There has been many more similar declarations which we do not definitely recall at the present writing.

The main point is that wherever official action has been taken or wherever republicans have done all the voting the result has been for Taft with great uniformity. And it will continue to become more and more so.
