The disease which has resulted in the death of 5,000 head of horses in western Kansas and probably 2,000 in southwestern Nebraska is pronounced spinal meningitis. There seems to be no cure for the trouble, and in describing the disease one farmer living near Holdrege says: After the disease becomes apparent the animal may live a week, but more frequently not to exceed three days and often death comes within twelve hours. The first sign is when the horse gets off its feed. For a few hours it stands around sort of dumpish and then it is attacked by a stiff neck. Frequently the head will be drawn until the nose of the ani mal points out almost horizontal with the body. Almost immediately the spine seems to become the seat of the disease and the annimal will hardly be able to move. In many instances there is a slight running at the nostrils and occasionally a hacking cough.

Efficiency That Should Count.

Under Roosevelt, the expenditures of the government for oridnary running expenses increased each year, until the aggregate total reached the highest in history, \$662,000,000. At the same time, a surplus of \$90,000,000 in 1902 became a deficit of \$58,000,000 in 1909. During that period of seven years the ordinary expenditures of the government inincreased \$191,000,000 or 40 per cent.




