REPRESENTATIVE STEVENS' ADDRESS.

To the People of Lincoln County.

Knowing my positive unworthiness and lack of ability to represent the thrifty and intelligent people of our county in the legislature, I made no particular effort to win the election as representative from the 68th district; but as the voters of the county give me such a handsome majority, and as the time for me to take my seat is near I take this method of expressing my appreciation of the honor shown me, and submit herewith my position as to the vital questions which are not only before the people, but questions which will come up at this coming session of our legislature.

Believing, as I do, in the wonderful and un-developed agricultural possibilities of Western Nebraska, I can easily advocate and stand for all legislation that has for its prime motive any measure will bring about better results for those engaged in tilling the soil for a livelihood.

The needed legislation to encourage irrigation in our county, and farther west in Nebraska, must not be neglected and I think as farmers and business men we are in unison in this matter. To this end I pledge all my constructive energy and co-operation with my colleagues.

Our various experimental farms agricultural schools and all public institutions need appropriations which will permit their advancement as well as their existence. To all these matters, and to our great Nebraska University, I intend to support as needed and expected of each loyal legislator.

I stand for Mother's Pensions, Woman Suffrage, the maintenance of the eight o'clock closing law and if a measure for county option comes up I shall support it to the last ditch.

To the farmer, who works the longest hours and receives a less per cent income from money, time and energy expended, than any man, or set of men in business, I shall pledge myself for his interest at all times.

To the corporation or special interest seeking and promoting legislation which

will work a hardship upon the many and extend financial advantage to the few, I shall put forth bitter and constant, and I hope effective antagonism.

I believe that the Liquor Dealers Association of Nebraska should be thrown entirely out of politics and I think that a county option law will be the first blow to that strong and corrupt organization.

I invite and urge the co-operation of all constituents to bring about useful and economical legislation and realize that I am your servant to do and to represent you in as honorable and upright a manner as is possible for me to do.

In making this brief campaign, I made but one promise, that, to support the peoples choice for U. S. Senator. That pledge will be fulfilled. I make my second promise to the voters now: I will not, at any time, cross the threshold of any lobbyist's expensive suite of rooms, knowing it to be such, being full aware that the rights of the people can be decided and chosen without consultation with any human vulture who represents selfish and special interests of some grasping and unrighteous organizations, whose end is to control the rights of the people in general. Any man lobbying for an unreasonable and unrighteous cause, I will not only ignore but hold in utter contempt.

I am a firm believer in the recall and at any time will submit to such, if the popular demand of the constituency prevails.

As I have struggled and attempted to build up a business here in Lincoln county along perfectly legitimate lines, so will I use that same constructive energy to bring about beneficial and economical legislation during this session of the legislature.

I have a desire to go to Lincoln with the name of every voter in Lincoln county in my pocket, and I herewith ask the men who have charge of the poll books to furnish me, as far as possible, the names of every voter therein, regardless of his political faith.

COLONEL CODY'S PROGRAM FOR NEXT YEAR.

In referring to the plans for the Buffalo Bill Wild West and Pawnee Bill Far East shows, Col. Cody says to the New York Clipper of Nov. 23rd.

I will not be in the saddle the coming season, but I will be with the show and appear at every performance. It will be my pleasure to meet my friends, and the public and to introduce Major Gordon W. Lillie as my successor. "The Two Bills' Show," will be materially strengthened in every department, and we will introduce a number of spectacular novelties and extraordinary features.

It may interest the readers of The Old Reliable to know that I will participate in the inaugural parade in Washington next March, representing in a rather novel manner the three states, Nebraska, Wyoming and Arizona, in which I have varied interests. Accompanying me in the pageant will be Indian chiefs from Nebraska, Indians and cowboys and ranchmen from Wyoming, and miners from Arizona.

I have taken part in many inaugurations in Washington, but I am frank to say that I am looking forward to the coming event as being one of the most pleasurable experiences in my rather variegated career in this and other lands.

Col. Cody informed their correspondent that there will be a street parade with the "Two Bill Shows" next season and that it would be an elaborate affair. It will be the aim of the management according to the Colonel to provide a street spectacle such as has not been witnessed here to fore with a

wild west organization. As general director, Col. Cody will receive his friends, officials and the newspaper fraternity in a specially erected office tent, which will be located immediately adjacent to the main entrance to the big shows.

The Colonel will pursue a unique method of personally introducing his successor, Major Lillie, to the audiences. Major Lillie will introduce the congress of the rough riders of the world and the Indian contingent at the opening of the exhibition, and just before the conclusion of the entertainment Col. Cody will ride into the arena behind a pair of spanking bays, in an equipage with driver and footman in full livery. This will be a la P. T. Barnum, who it will be recalled, made speeches during the performance of the Barnum & Bailey greatest show on earth, incidentally introducing his successor, James A. Bailey.

In centering the direct attention of the vast audiences who will undoubtedly attend the Wild West exhibitions next season to Major Lillie, upon whose shoulders will fall the mantle of the "hero horseman of the world" it will not only prove a novel, but a most affective manner of bringing the Major into general prominence such as perhaps he could not otherwise have.

Since he came before the public as an entertainer Col. Cody has won the admiration of almost every nation in the world. Before entering the amusement arena he had served his country in a gallant manner and it will be with a feeling of sincere regret to learn that his days in the saddle are over.

Council Proceedings.

The city council met in regular session in the library building Tuesday evening with all members present. The report of Special Examiner Hoagland on the treasurer's and clerk's books were read and approved. (A full copy of said report will be published later in the paper.)

The usual monthly reports of the city treasurer, police judge, clerk and water commissioner were received and placed on file.

The fire insurance occupation tax collected for the year amounting to \$155 was ordered turned over to the fire department, this being the usual custom.

The attention of the council was called by the street commissioner that there were several places in town where water from roofs through main apouts was permitted to run on the sidewalks and that in the winter this water would freeze and was liable to cause the city some damage suits. Upon motion the street commissioner was instructed to notify all property owners, where this was the case, to provide some other way to drain off the water. He was especially instructed to look after the drainage of the Lock building, where the Davis garage is located.

The clerk was instructed to notify Mr. B. A. Wilson for him to make a proposition to the city, with reference to opening up the street on the west side of his property, block 185, at the next regular meeting of the council.

The ordinance regulating the riding of bicycles in the city and especially with reference to riding on sidewalks and repealing all former ordinances was passed (a copy of said ordinance is published elsewhere.) All bills on file were allowed.

There being no further business the council adjourned. C. F. TEMPLE, Clerk.



Ordinance No. 26. BICYCLES.

An ordinance regulating the use of bicycles on the streets and sidewalks of the city of North Platte, Nebraska, and providing a penalty for the violation of the provisions of said ordinance.

Be it ordained by the mayor and city council of the city of North Platte, Nebraska:

Section 1. Riding on Sidewalks. It shall be unlawful for any person to ride a bicycle upon the sidewalks of the city of North Platte, Nebraska, upon either side of Locust street from 3rd to 10th street; upon either side of Dewey street from 3d to Front street; upon the west side of Pine street from 4th to Front street; upon either side of 4th, 5th, 6th and Front streets from Locust to Pine streets, respectively.

Section 2. Speed. It shall be unlawful for the persons to ride bicycles more than two abreast upon the sidewalks of the city of North Platte, Nebraska, and it shall be unlawful for them to ride at a rate exceeding eight miles per hour.

Section 3. Exceptions. It shall be unlawful for any person to ride a bicycle upon the sidewalks of the city of North Platte, Nebraska, at any time except when the streets of the said city of North Platte are in such a condition by reason of rain, snow or other cause that a bicycle cannot be safely ridden thereon. When riding upon the sidewalks as above specified every person upon meeting or passing a pedestrian or person standing upon the sidewalk shall dismount from his or her wheel and shall walk past such pedestrian or person before mounting.

Section 4. Lamps. It shall be unlawful for any person to ride a bicycle within the corporate limits of the city of North Platte, Nebraska, after it begins to grow dark unless there is attached to the front of said bicycle a lighted bicycle lamp.

Section 5. Passing. It shall be the duty of every person riding a bicycle to turn to the right upon meeting any vehicle or pedestrian.

Section 6. Penalty. Any person violating any of the provisions of this ordinance shall upon conviction thereof be fined in any sum not exceeding five dollars, and shall be adjudged to pay the cost of the prosecution and may be committed to the city jail of North Platte, Nebraska, until fine and costs are paid, or until otherwise discharged according to law.

Section 7. Repealing Section. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

This ordinance shall be in force on and after its passage and publication according to law.
