A Successful Homesteader.

Henry B. Attebery, living seventeen miles northwest of Sutherland, called at the U. S. land office a few days ago to receive the patent for his homestead. Mr. Attebery took his claim in the spring of 1909, and prior to that time had worked as a carpenter in the east part of the state, and lived in sort of a hand to mouth fashion. When he arrived on the homestead he had \$70 in cash, a plug of a team and a wagon which he purchased on time, and a wife and five children. He put up a sod house for summer shelter, and and Mrs. Nels Hammer. bought a plow and cultivator, paying part cash and securing credit for the remainder. Today he has good homestead buildings, seventeen head of horses, twenty head of cattle, 105 latter part of last week to visit relaacres in cern, 70 acres in wheat and rye, a deed to 640 acres of land worth \$4,000 or \$5000 and doesn't owe a penny. Flow of Water in the River.

According to the records in the office of Division Superintendent R. H. Willis the Pathfinder reservoir reached its maximum storage on June 16th this year, when it showed 634,760 acre feet. The inflow on June 24, 1913, was 2100 second feet, and the outflow on the same date was 3,200 second feet, while the storage was 622,590 acre feet.

On June 26 there was flowing past Whalen, Wyo., 2,246 second feet; there was flowing into Nebraska on June 25, 3,058 second feet, and past Bridgeport on the 26th, 1,080 second feet.




