INTERESTING FACTS ABOUT OUR SCHOOL POPULATION

Census of District Shows 1641 Children of School Age; 752 of Whom were Born in the City.

The census of the North Platte City school district for 1914 shows 1641 children of school age residing within the limits of the district. Of this number 812 are girls and 829 are boys. The largest family has four girls and five boys of school age and the second largest has six girls and two boys, between the ages of four and twenty-one. There are 735 families having children in the school census and of this number 143 families are represented by just one boy and 154 have just one girl. This makes a total of almost 300 families who send but one child to school. Of the 1641 children in the census, one was born in Japan, six in England, one in Greece seven in Germany and three in Sweden. All the rest were given as born in the United States. Of those born in the United States, a great majority were born somewhere in Nebraska. Neighboring states furnished the birthplace of pupils as follows: Iowa sixty-five, Kansas fifty-five, Colorado thirty-nine, Missouri thirty-two, Wyoming twenty-five, Illinois twenty-five, South Dakota eighteen, Oklahoma fourteen, Michigan eight, Pennsylvania Minnesota and Indiana the same, Kentucky, Oregon and New York each five, Maine and Wisconsin three, Idaho, California, Virginia, New Jersey and Utah each two, while Texas, Montana, Ohio and Washington each have one birthplace. Altogether twenty-seven states are represented. Only 752 out of the 1641 children were born in North Platte. Another seventy-nine were born in Lincoln county outside of North Platte. Adding the two together we have a bare one-half of the school population who were born within the borders of this big county. Omaha sent us twenty-six, Grand Island fifteen, Kearney eight, Lincoln ten, and York seven. And yet the schools of the city are expected to take this group of children, descended from parents who have blood from almost every nation, and they themselves of every possible condition of culture, means and racial characteristic, and put them in the common mould of conventional learning and turn them out good citizens.
