ENGINEMEN DEMAND END OF SURPRISE TEST

The railroad wage and arbitration board, sitting in Chicago, will reconvene Monday after the holiday recess. For a few days before adjournment last week the surprise or efficiency tests were strongly argued. These arguments brought from Warren S. Stone and William S. Carter, representing the men, statements that if certain features of the tests objectionable to the men were not eliminated by the arbiters the men would strike. Mr. Carter said the men first asked the courts and the board to protect them. from practices condemned by rallroad rules themselves.

W. L. Park, vice-president of the Il-Bnois Central and member of the board of arbitration, read a long statement quoting largely from an interstate commerce monimission report, and declared he required a preponderance of evidence as to the danger of "surprise tests" before he would vote to eliminate them, as requested by the

Mr. Park said the tests were made necessary because the commission had reported that 52 out of 81 accidents in which persons were killed occurred because employes had disregarded signals or company rules. Thirteen of these accidents, he said, occurred despite the automatic block signal sys-

The men complain that tests are made in such a way that the locomotive crews become alarmed and sometimes leap from their engines after setting the brakes.

The firemen told, generally, stories of men laid off and promotion deferred by the advent of heavy locomotives, of long hours and scant pay, the latter depleted by expenditures when away from home. C. B. Vance, employed by the Illinois Central railroad, who from time to time has "fired" a pasrenger locomotive, said that no one fun run the evew was so shaken by vibrations of the big locomotive that chains were strung between it and the tender also, so they could

It appeared from the testimony that on the heaviest locomotives one fireman could not do all the work required and was assisted by the engineer. The men claim that on such locomotives an assistant fireman should be provided. It was declared also that violations of the 16-hour law were frequent.
