NINE OF PRESENT TEACHING CORPS WILL LEAVE.

North Platte City Schools lose the following teachers for next year: Miss Julia Mansfield to Mexico, Mo.; Miss Hazel Wheeler to Hastings, Neb.; Miss Ellen Anderson to Douglas, Wyo.; E. H. Flowers to Ottumwa, Ia.; Miss Ruby Manuel to Kearney, Neb.; D. J. Brenne-man to Lowell, Neb.; Miss Maude Rees (location undecided); Miss Anna Farrell to Fonda, Iowa; Miss Bessie Crandall to Douglas, Wyo.

Among the new teachers elected by the board who have accepted positions are: Miss Gertrude Baker from Gothenburg; Miss Gertrude McHugh from Alliance; Clayton Pearson from Alinsworth, Iowa.

The relation of the Junior High school to the Senior high school has not been definitely established yet and it has been decided to work it out by experience rather than by guess. The board of education has appointed Miss Grace Holman of the Senior high school as the head of the new Junior High with the title vice-principal. In some places the Junior high school is under the jurisdiction of the principal of the Senior high school in matters which affect both the schools, such as discipline on the school grounds, pupils of one school interfering with pupils of the other, the use of the gymnasium, dressing rooms, etc. In other schools each school is an independent unit and each has a principal who is directly responsible to the superintendent.

Supt. Tout is arranging an exhibition of photographs of the different interests of the North Platte City schools for the educational department of the Nebraska State Fair at Lincoln next fall. This exhibition will have pictures of the different school buildings, some of the classes, playground activities, the different societies and other interests of the high school and co-operative interests of the city.

Graduation exercises will be held at the Keith theatre on the evening of May 24th. Thirty-four pupils will be given diplomas at that time.

CITY COUNCIL MEETS IN REGULAR SESSION.

The city council met in regular session Tuesday evening, but other than discussing paving and park matters, transacted but little business.

A petition signed by fifty railroad men, asked that a 250-candle power be placed on north Lincoln avenue, in order to furnish light to enable round-house employees and engine and train men to see their way to the lighted street. The petition was referred to the light committee.

A petition from a majority of the property owners in blocks 33 to 44, between Tenth and Eleventh streets, asked that a lateral sewer district be created of those blocks. The city attorney was instructed to draft an ordinance forming the district.

The building district ordinance, drawn and suggested by Architect Reynolds was referred to the ordinance committee.

The salary of the clerk in the water commissioner's office was raised from \$40 to \$65 per month, on a showing that the clerk was greatly underpaid for the work performed.

Two members of the park board were present and informally discussed park matters with the council.

Dr. J. A. Stansfield, of Denver, who came as a substitute in place of Dr. Percy Weber, of Boston, closed a successful eight-day mission at the Episcopal church Tuesday evening. The services were held daily and the attendance at the three meetings each day was very encouraging. Dr. Stansfield delivered very eloquent and instructive sermons and special meetings for the ladies' guild and high school pupils were held Tuesday.

William O'Connell was called to Ely, Nevada, Tuesday by a message which stated that his brother Steve McConnell, a conductor on the railroad there had been killed in a railroad accident. The deceased was about forty years of age and twenty years ago was employed here as conductor on the Union Pacific. He was unmarried and the remains will be brought here for burial.

The funeral of the late Hiram Timmer who died the first of this week was held from the Lutheran church Wednesday afternoon. Rev. Harman delivered an impressive sermon and many friends of the deceased attended the services. Interment was made in the North Platte cemetery.

Mrs. H. I. Block who left several weeks ago for New York to attend the funeral of her father, contracted a severe cold while in Syracuse and has been bedfast for some time. Her condition is such that her return will be delayed three weeks.
