SAM M. SOUDER.

Republican Candidate for County Treasurer.



Sam M. Souder, the republican candidate for County Treasurer, was born in Washington county, Nebraska, in 1886 and moved to Deer Creek Precinct, Lincoln county, with his parents in 1892, where he has since spent most of his time. Captain Halligan was born in Ogalalla in 1887, came to North Platte in 1895 where he has since resided. He graduated from the North Platte High School in 1906; from the Academic Department of the State University in 1910, and from the Law Department of the State University in 1912; after his graduation he became associated with the firm of Wilcox and Halligan and has practiced law in Lincoln County in connection with that firm up to July 1st, 1916, when he enlisted in Company E, 5th Nebraska Infantry, and was by the company elected Captain, with his company he was mustered into the United States Army shortly after and was sent to the border where he is at the present time.

When the Company was mustered into the United States service it was thought war with Mexico was inevitable, but it is now conceded that there will be no war with Mexico, and Captain Halligan is expected to be home before election.

The Nebraska troops are the next troops in line to be ordered home, and it is now expected that they will be sent back not later than November 1st; in any event it may be stated positively that if elected Captain Halligan will be on hand to assume the duties of his office January first, 1917.

Captain Halligan was appointed County Attorney of Arthur County in 1914 and has acted in that capacity for that County up to the present time. He had charge of a case in the Supreme Court for Arthur County involving the legal existence and organization of Arthur County, and after a hotly contested case won against distinguished counsel; and at this time he has charge of a case for Arthur County in the Supreme Court involving a strip of territory about four miles wide running the entire length of Arthur County and claimed by both Arthur and Garden Counties.

Should Captain Halligan be elected he will conduct the legal affairs of this county without the county being put to the expense of hiring extra legal talent to assist the County Attorney, a thing which has cost Lincoln County large sums in the past.

Furthermore if elected he will enforce every law upon the Statutes including the prohibitory amendment if the same is adopted.

Captain Halligan is not here during the campaign but is on the border wearing the uniform of his country in obedience to the call of the President for men to protect the border against the murderous invasion of Mexicans.

Surely the patriotic people of Lincoln County will concede that he is excused for not being present in the campaign, and on election day will see to it that his interests are protected.
