COUNTY ROADS CAUSE CAUSE "GRIEF" FOR COMMISSIONERS

Present and past county commissioners agree that county roads are the cause of more "grief" for the commissioners than any other phase of their work. This is due to the fact that as a rule there are contending factions when a road is petitioned for and a fight follows. Then again the question of damages creates more or less contention, the land owners often demanding much more for the land required for the road than it is worth and greater than the damage he suf-Another drawback is that the fers. road levy, up to the limit, creates losa money than is needed, and action on petitions is delayed by reason of lack of funds.

At the present time there are on file with the commissioners twenty petitions for new roads or extensions to existing roads, and to open them and pay the damages which the land owners ask means a big expenditure of money. In addition to these petitions, about an equal number of roads have been granted, but upon which the damages have not been paid. These dam- friends. ages amounting to \$5,000 or \$7,000. have not been paid by reason of lack of funds. Only part of these roads

have been opened for travel. The road levy creates about \$20,000 sum that is needed to open the new and two fours. roads demanded and keep in good repair those already in use. To expend \$20,000 where \$40,000 is needed and at the same time to keep the road users in good humor requires tact, diplomacy and good financiering on the part of the commissioners.
