NEWS RELATING TO. EXISTING STATE OF WAR

The house of representatives passed the war resolution Friday forenoon immediately following President Wilson issued a proclamation deciaring a state of war existing be-tween the United States and Germany, Ninety-due German ships interned at U. S ports were taken over by our government.

The war council and the president have planned an army of 2,000,000 and the president is insistent that congrees make provision for the maintenance of one million men at once.

Thirty-two suspected German spies were arrested in Chicago Saturday and many others in different sections of the country.

A German raider is reported to have been sighted off Nantucket lightship Saturday. Nantucket shoals are only eighty-five miles east of the naval base at Newport. The navy department at once proceeded to get all ships under cover Investigation by officers of the American army showed that the repors of German reservists crossing from the United States into Mexico have been exaggerated and that the total number crossing the Rio Grande since the breaking of relations with Germany up to ten days ago was not more than 100. Early entrance of several of the South and Coutral American nations into the war against Germany is regarded as practically certain. Brazil, aroused by the sinking of its steamer Parana, is expected to become a belligerent this week and it is assumed that its lead will be followed promptly by other countries,

Cuba, not yet out of her teens as a tries to range herself alongside the United States, her liberator and protector, Saturday President Menocal affixed his signature to the joint resolution passed unantmously by both the senate and the house without a dissenting voice being raised, thus putting into effet the declaration that a state of war exists between Cuba and the imperial German government.

Austria-Hungary, under the pressure of Germany, has severed diplomatic relations with the United States. Baron Drick Zweidinek, charge d' af fairs of the Austrol-Hungarian cunbassy at Washington, called at the State department yesterday and asked for passports for himself and the embassy staff. Almost at the same time a dispatch was received from American Minister Stovall at Berne saying the dual monarchy had brokn off diplomatic relations with the United States. in Vienna Sunday.

Congress will immediately author ize the issuance of three billion dollars in bonds to finance the allies and two billion to maintain our own army

In making a long distance telephone call you have the use of more than merely the wires over which you talk.

The wires are only a small part of the equipment provided for a long distance call. There must be switchboards, terminal rooms, pole lines and many other kinds of apparatus such as dynamos, batteries, calculagraphs, testing apparatus, repeaters and loading coils to magnify the voice currents, and other expensive equipment generally unseen by the telephone user.

In making a long distance call you have the services of two or more operators who connect you and guard both ends of the line while you talk.


In addition to the operators there are other employees watching the equipment in the central offices and repairmen guarding the long distance wires.

Repairmer Always Ready

Somewhere along the line, the branch of a tree, a strong wind or an electric storm may put the wires out of order. , But nearby is a telephone man ready to hurry to the spot, so that the line may be quickly repaired and service restored.

The amount you are charged when you make a long distance call is to help maintain the line, to facilitate the payment of interest on the investment in the equipment used for long distance, to aid in the payment of taxes on the property and assist in paying the employees' wages.

We endeavor to obtain only such a return on the investment in our long distance lines as could be earned on the money if it were invested in any other business involving equal risk.
