America's program of war and peace, with definite terms upon which the nations, great and small, fighting together against German world domination are ready to lay down their \$9.95 arms, was given to the world by President Wilson Tuesday thru an address to congress in joint session. For this program, based upon the fighting \$12.50. of wrongs and the safety of peaceloving peoples desiring to live their own lives, the president committed the United tSates to fight and continue to \$275.00. fight until it is achieved. 
