Wheat Shortage is Acate.

Imperative orders restricting mill operations the remaining four months the crop year were issued last week by the milling division of the food administration. The need of distributing the rest of the wheat crop evenly until the next harvest, and of reducing domestic prompted the move. consemption.

Reports on the movement of wheat and receipts at central markets the past months have indicated that the acute stage of the wheat supply situation is approaching faster than expected. All mills in the Kansas City zone are restricted to 75 per ceni of their normal output prior to this year Those that have reached that limit must close at once and others must distribute their remaining allotment thru the next four months. The order means a large reduction in the production of flour between now and next July

The evident shortage of wheat must result in a steadily increasing domand for substitutes. Orders of the food administration recently issued requiring wholesalers and retail dealers to sell no flour except to purchasers taking proportionate amounts of other cereal products already has greatly sumulat. ed demand for corn, oats and barley. 


