Pooled carlot purchases of Nebras ka grown and graded potatoes are urgeda by Gurdon W. Wattles, Federal Food Administrator for Nebraska.

Mr. Wattles is making this recom asking them to urge upon the retailors at 914 west Fourth or phone Red 344. of their counties these pooled purchases.

Such purchases, says Wattles, will decrease the cost of potatoes and Cotner university to enlist in the at less cost. Retailers of the cities and towns of the state are urged to get together and buy Nebraska potatoes and to divide them after shipment.

Investigations by Wattles develop ed the fact that a large part of the cost of potatoes to the consumer comes from duplicate and unnecessary transportation and from additional expense in handling small shipments. By the pooled carlot purchases, these items will be practically eliminated.



Red Cross Work Must Continue.

In a letter to President Seeberger the War Council of the American Red Cross says:

Let no one suppose that the work of the Red Cross is finished. Millions of American boys are still under arms. Thousands of them are sick or wounded. Owing to the shortage of shipping it may take a year or more to bring our boys home from France. But whatever the time, our protecting arms must be about them and their families over the whole period which must elapse before the normal life of peace can be resumed.

Our soldiers and sailors are enlisted until the commander in chief tells them there is no more work for them to do in the war. Lot every Red Cross roumber and workers show our retturning soldiers and sallors that to care for their health, welfare and happiness we are enlisted for no less a period than they are.

The cessation of the war will reveal a picture of misery such as the world has never seen before, especially in the many countries which cannot help themselves. The American people will expect the Red Cross to continue to act as their agent in repairing broken spirits and broken bodies. Peace terms and peace conditions will determine how we may best administer to the vast stricken areas which have been harrowed by the war and in this out act of mercy the heart and spirit n the American people must continue to be mobilized through the American I Cross

In behalf of the War Council, we "dingly ask each member of our lengil body of workers throughout. to hear in mind the solemn 'ration which rests upon each one "marry on."
