### MEN IN THE CAMPS WILL SOON BE STARTED HOME.

Gen. March stated Saturday afternoon that demobilizatio of the American army was already under way, but that ample provisions were made to look after the needs of a standing army, the size of which would be determined later

He stated that there were one million seven hundred thousand men in camp in this country and that the first two hundred thousand men would be enroute home in two weeks. The men discharged will be given one month added pay and an opportunity to reonlist. They will be permitted to wear their soldier uniforms unfil three weeks after their discharge.

The men in cantonments will be discharged in the following order: Development battalions, conscientious objectors not confined to prison, the spruce workers and producers, central garden would be worth \$20, which school of officers, U. S. guards, rallroad troops, depot brigade members, depot brigade men in replacement camps and men in combat divisions.

This is the general order in which men are to be returned, it being the intention to concentrate them at the camps nearest their homes before giving them their discharge.

## Germany's Debt to France.
