Instead of being a help to the enforcement of state laws and city ordinances, we have been the reverse; we stand on the street corners and laugh or jeer at attempts that are made to improve conditions; we conclude, without investigation, that such attempts are insincere; we demand that certain things be done and if they are done we criticize the officer doing it because it was not done in some other way. We never have a good word for the mayor or his police, no matter who the mayor or the Give will be sent along as navigator. police may be or how sincere their desire to do good. As citizens we fault the administration for moral conditions, whereas if we were honest we would fault ourselves for our lack of courage in doing, or assisting to do, those things which the right standard of citizenship requires of us. If we are sincere in our demand for a cleaner town we should do our part, and not leave it wholly to the mayor or the police force. The fact is we are too cowardly to do our duty and use the mayor and police to screen our cowardice. We content ourselves by saying it is not our duty to see that laws are enforced; we delegate that work to the men who are paid for doing it; yet we all know that as good citizens we should file complaints against those whom we are certain have violated a law or fractured a city ordinance, without relying on the police, and yet who of us ever do so? Let us as individual citizens pledge ourselves to support the new mayor and the police force, whoever they may be; let us cease continually and infernally belittling them, and by so nearly perfect as it is possible to els Kershon oats; good for seed. have them.

A British trans-Atlantic airplane the building of which has been kept a secret until the present time, will be shipped to New Brunswick within a few days to attempt a flight from New Brunswick to Ireland, according to a statement made by the London Mail. 

Regulations governing the payment of \$60 bonus to honorably discharged soldiers were amended by the war department to permit the acceptance by disbursing officials of a "true copy" of discharge certificates. Heretofore the original certificates were required. but it was found that many soldiers refused to part with the papers, preferring to lose the bonus rather than risk the loss of official evidence of their honorable release.

All copies submitted under the amendment authorized must be certified by the army recruiting officer nearest the soldier's residence.


