HOUSEHOLDER MAY KEEP LIQUOR FOR OWN USE.

Under the national prohibition bill passed by the lower house of Congress Tuesday it is not illegal to have in one's possession liquor in a private dwelling while the same is occupied and used , by the possessor as his private dwelling, and the liquor is used for personal consumption by the

owner, his family or his guests. The possessor of such liquors however, bears the burden of proof that the liquor was acquired and is possessed lawfully. Intoxicating liquor is defined as a beverage containing more than 1/2

per cent of alcohol. Any house, boat, vehicle, or other place where liquor is manufactured or sold is declared a nusiance.

No person shall manufacture, sell barter, give away, transport, import. export, deliver, furnish or receive any intoxicating liquors.

Liquor for non-beverage purposes, and wine for sacramental usa may be sold under specified regulations.


