Under this scheme it is proposed to grant the degree of bachelor of commerce to candidates who pass the necessary examinations after a three years' course of study. Those who so desire may later proceed to the degree of master of commerce, after a minimum of two years' practical experience in the particular trade or industry taken up,

The first year's course comprises the compulsory subjects of organization of Industry, banking, trade and transport; modern economic development of the British empire and of the chief foreign countries; elementary commercial law, and statistical method.
