Alliance .- Four thousand acres of rich Garden county hay and cattle lands, part of the famous Everett Eldred ranch have been restored to \$54.46. homestead entry under the Kinkaid act by the government according to announcement made here by the local United States land office. The federal \$171.00. court at St. Louis decided in April. 1919, that the title held by Eldred to the lands was not valid and cancelled the patents on the same.

Preference will be given to ex-soldiers in filing for the homesteads which will be thrown open to entry on July 23. The soldiera' preference period will extend from July 24 to September 25 inclusive All applications for homesteads must be accombanied by a filing fee of fourteen doilars which will be refunded if the applicant is unsuccessful. For a period of twenty days prior to July 23, soldiers may file their applications and the same will be disposed of by lot.
