Editor of the Tribune,
Dear Sir:

I am what might be called a transient, as I only make North Platte my home when I visit here. However as I go about your beautiful city and as I look at your many beautiful homes, I often ask myself if these are really homes. And I wonder if the parents in these homes give much earnest thought to the greatest asset in these homes—the boys and girls.

I am lead to believe there is plenty of money in North Platte to invest in any real enterprise that will bring good returns in dollars and cents to the investors. I wonder if an investment in real life for the boys and girls would arouse the same interest. I said I am a transient, but are we not all transients for that matter? And in this connection there comes to my mind the work of a very dear friend who after her conversion fifty-seven years ago felt called upon to devote her life to helping save those girls who had left home and gone astray. She went to the city and often at midnight without the aid of a policeman she would go to the slums and try and rescue the lost ones for whom Christ gave his life. She was successful in rescuing many and these she took to the home of which she was matron. Finally her own health broke down and she went to her home. When she died her last words were these—"I wish all

my friends could see how thin the veil is between the two worlds."

I wish to God there were men and women in the churches of North Platte who would feel the vision of the needs of the young people of this city. There are some who could set in motion the machinery which would help develop the highest ideals in our young men and women. I have heard several young men express their longing for a Y. M. C. A. in North Platte and this appealed to me in a very pathetic way. I hope and pray that sufficient interest may be aroused in the moral and religious element of this beautiful city so that they will take those steps in this matter which will promote interest in the very best things in moral and christian citizenship. And I want these things to be done ere more parents and citizens realize the bitter meaning of those words "It might have been."

MOUNTAIN GOAT WAS READY

And Eagle Knew Better Than to Force the Issue With Such an Adversary.

"The writer once witnessed a fight between a golden eagle and a full-grown mountain goat. This fight took place on a high divide in the Bull river country in British Columbia," says Charles S. Smith in an article in Boys' Life, entitled "The Rocky Mountain Sheep at Home."

"I was stalking the goat at the time for the purposes of taking some photographs as close up as I could get, and was working my way cautiously from rock to rock, keeping concealed from the goat, who was feeding on a little flat space on the top of the mountain. As I peered around the projecting point of a crag I saw the goat suddenly wheel and look toward a small point sticking up on top of the ridge and there, coming over the top of the point was a very large golden eagle, flying just above the surface of the ground and coming directly at the goat. The goat stood with head lowered and when the eagle came within about ten feet of him, it suddenly swooped into the air about fifteen or twenty feet high, turned completely over and dropped like a plummet at the goat. I wondered what the goat would do, but evidently he had it all figured out, for as the eagle descended he reared on his hind feet, stood straight up and slashed his head from side to side, his horns describing a circle in the air, his sharp points upward; the old eagle evidently knew better than to try to drop on a thing of that sort or to try to seize it, so he caught himself in his swift descent and volplaned over the side of the ridge; here over a deep, dark canyon he circled several times, the goat standing watching until he disappeared over the shoulder of the mountain."

Use for Knot Holes.
That a use has been found for the knot hole, which is regarded generally by lumbermen as of about as much value as the squeal of the hog, is vouched for in a story published by the American Lumberman.

Chicago packing houses are said to use all of the hog but the squeal, but a Yankee has gone this one better. Taking a piece of board one inch thick which has been cut off in some factory because of the knot hole which the piece contains, the Yankee squares the pieces with the knot hole centered, sets it upon a one-half inch wooden base, glues the two together, smooths the surfaces of the piece and gives it a bath of varnish. Behold, the piece is a wooden novelty suitable for the desk as a receptacle for paper clips, fasteners, pins, or the like!
