Wars have been waged over what should be the proper day for the celebration of Easter. Churches have been rent by differences of opinion as to how the festival should be observed. Easter has been the first day of the year, and, for hundreds of years at a time, there have been not one but often several Easters, each defended by its advocates. In the controversy both sun and moon have been called In to give testimony and since those two witnesses failed fully to agree there has grown up a difference, so that our Christian Easter might be called the sun Easter, whereas the near-by Passover of the Jews might be termed the moon easter or moon passover. #### HOLY PLACES IN JERUSALEM

Stations of the Cross Are Objects of the Most Solemn Reverence at Easter Time.

The stations of the cross, the eighth of which is shown in the illustration, are the objects of solemn reverence in Jerusalem on Easter. The 14 stations are supposed to fix the site of the chief events on the path of Christ from Pilate's hall to Calvary, 'The irst station is in the barracks on the ite of the castle of Antonio, Here 'hrist was condemned to death. The second station marks the spot where the cross was laid upon Christ. At the third station Christ is said to have sunk under the weight of the cross. At the fourth station Christ is belleved to have met His mother. The fifth station on the sorrowful way is where Simon of Cyrene relieved Christ of the cross. At the sixth station is the house of Saint Veronica who is said to have wlped the Savior's brow with her yell. The seventh station is at the Porta Judiclaria where Christ fell a second time under the cross. It is at the eighth station that Jesus comforted the women of Jerusalem. The ninth station is in front of the Coptic monastery. Stations ten, eleven, twelve and thirteen are in the Golgotha chapels of the church of the Holy Sepulchre, marking the spots where Jesus was disrobed and fastened to



Many priceless lamps hang before the marble-topped tomb, now one of the most venerated altars in Christendom. The traditional Gethsemane is on the side of the Mount of Olives across the Kedron. The garden is at present a walled enclosure cared for by Franciscan monks who bestow great attention on eight ancient olive trees supposed to be remnants of a grove standing at the time of Christ's agony.

Upon each of the great stations of our calendar year we instinctively minate. pause and give thought to certain phases of life, to close our accounts with the past and to open a new and a clean page. At January 1 our thoughts are apt to be material, to relate to our physical deeds of the past and our promises of betterment in the future.
