DEMONSTRATES MAKING OF A FOR CHILDREN'S BIRTHDAY GIVE COMMUNITY PROGRAM OF WORK

A FURE-BRED FIG OR CALE

A demonstration of the development of a community program of extension work was given at the annual conference of Louisiana extension agents of the United States Department of Agriculture and the State agricultural college, held in Battin Rouge in August. A program for a near-by community was completed before an audience of extension agents and farmers, who discussed the leading agricultural interests of this community Sand what they considered the most pressing problems.

The demonstration showed that extension agent should make a close study of the community before attempting the formation of any program, and must use care, patience and skillful questioning at the conference of the community program committee in determining the real problems. When the program is completed, the demonstrations should be followed by well-planned meetings, tours, and other publicity in order to get the largest possible number of people to accept the practices which the demonstrations have shown to be worth while locally.


