Interest in the election of county officials overshadows that in the state candidates. While finance is the basis of most of the talk, there are many factors entering into the campaign which extended from the wet and dry question on to how a man treats his wife or whether he pays his debts or not. At this writing Souder is considered safe, Lowe will defeat Allen and it is a close race between Salisbury and Berthe. Earlier in the campaign there was a tendency to turn all the present county officers out but the sober second sense has come to the front and it is seen that Souder is too valuable a man to leave out. The sentiment for register of deeds is difficult to get as both of the candidates are only fairly well known and most people do not appreciate the importance of the office. With county clerk it is different. Most of the people of the county come in contact with him in some relation or another and Theo. Lowe is too valuable a man to pass up when this office is to be filled. It is certain that he has the qualifications and that the farmers and laboring people are back of him. Thos. Axtell for representative is also receiving much favorable comment. He is a fine man personally and while nominated on the Progressive ticket and not bearing the prestige of either of the older parties he is making quite an impression on the voters. Wells Jones and Paul Meyer will probably be elected by good majorities. They have no opposition.

POWERFUL PICTURE "THE OLD HOMESTEAD" COMES TO THE KEITH
