Mark Hanna will be at Auburn Saturday, October 20th, at 1:15 o'clock p. m. He will stop about 30 minutes and will make an address at the Amphitheater on the fair grounds.

Sam Shuck, Ed Paris and Henry Plasters, who have been visiting in Webster county, Nebraska, and Smith and Jewell county, Kansas, for the last month, returned home Tuesday. Sam was so well pleased with the country that he bought a farm of 160 acres six miles southwest of Red Cloud. He reports all former Nemaha county people doing well and apparently pleased with the change. Sam brought back with him some samples of corn from Smith, Jewell and Webster counties. The members of the Nemaha County Old Settlers association met at The Advertiser office last Saturday afternoon and held the annual election of officers.

Ex-Gov. Robt. W. Furnas, of Brownville, was elected president.

The executive committee elected Seymour Howe vice president, W. W. Sanders secretary and W. T. Russell treasurer.

The association, in addition to paying regular expenses, built an addition to the band stand costing about \$18, and paid about \$28 on indebtedness contracted last year, leaving the association nearly \$23 in debt yet.

The glee club then sang "The Woodchuck and the Coon." M. S. McIninch then spoke for thirty minutes, making a fine argumentative speech. Mr. McIninch is doing some good campaign work. Misses Florence Minick and Veva Clark sang a duet. "When the Poppies Fade." Hon. Norris Brown of Kearney then spoke for an hour and fifteen minutes, making a splendid address. He was frequently interrupted by hearty applause. The meeting was closed with a song by the glee club, "The Second Battle." The boys had a big bonfire and as a consequence dry goods boxes were scarce the next morning.

G. N. Titus did not make a speech as he requested that he be not called on. Nat does not need to make any speech in Nemaha.
