## **PROPOSED** CONSTITUTIONAL **AMENDMENTS**

The following proposed amendments to the Constitution of the State of Nebraska, as hereinafter set forth in full, are submitted to the electors of the State of Nebraska, to be voted upon at the general election to be held Tuesday, November 3, A. D., 1896:

A joint resolution proposing to amend sections two (2), four (4), and five (5,) of article six (6) of the Constitution of the State of Nebraska, relating to number of judges of the supreme court and their term of office.

ing to number of judges of the supreme court and their term of office.

Be it resolved and enucted by the Legislature of the State of Nebraska:

Section 1. That section two (2) of article six (6) of the Constitution of the State of Nebraska be amended so as to read as follows:

Section 2. The supreme court shall until otherwise provided by law, consist of five (6) judges, a majority of whom shall be necessary to form a quorum or to pronounce a decision. It shall have original jurisdiction in cases relating to revenue, civil cases in which the state shall be a party, mandamus, quo warranto, habeas corpus, and such appellate jurisdiction, as may be provided by law.

Section 2. That section four (4) of article six (6) of the Contsitution of the State of Nebraska, be amended so as to read as follows:

Section 4. The judges of the supreme court shall be elected by the electors of the state at large, and their term of office, except as hereinafter provided, shall be for a period of not less than five (5) years as the legislature may prescribe.

Section 3. That section five (6) of article six (6) of the Constitution of the State of Nebraska, be amended to read as follows:

Section 5. At the first general election to be held in the year 1836, there shall be elected two (2) judges of the supreme court one of whom shall be elected for a term of two (2) years, and at each general election thereafter, there shall be elected one judge of the supreme court whose terms have not expired at the time of holding the general election of 1896, shall continue to hold their office for the remainder of the term for which they were respectively commissioned.

Bec. 13 The judges of the supreme and district courts shall receive for their services such compensation as may be provided by law, payable quarterly.

The legislature shall at its first session after the adoption of this amendment, three-fifths of the members elected to each house concurring, establish their compensation. The compensation so established shall not be changed oftener than once in four years, and in no event unless two-thirds of the members elected to each house of the legislature concurtherein.

The officers of the executive department of the state government shall receive for their services a compensation to be established by law, which shall be neither increased nor diminished during the term for which they shall not receive to their own use any fees, costs, interests, upon public moneys in their hands or unposed to their own use any fees, costs, interests, upon public moneys in their hands or upon public moneys in their hands or upon public moneys in their hands or interests of the compensation and all fees that may hereafter be payable by law for services performed by an officer provided for in this article shall be paid in advance into the state treasury. county lines; and such increase, or any
change in the boundaries of a district,
shall not vacate the office of any judge.

A joint resolution proposing to amend section six (6) of article one (1) of the Constitution of the State of Nebraska, relating to trial by jury.

Section 6. The right of trial by jury shall remain inviolate, but the legislature may provide that in civil action: five-sixths of the jury may render a verdict, and the legislature may also authorize trial by a jury of a less number than twelve men, in courts inferior to the district court.

A joint resolution proposing to amend section one (1) of article five (5) of the Constitution of Nebraska, relating to officers of the executive depart-

ment.

Be it resolved and enacted by the Legislature of the State of Nebraska:

Section 1. That section one (1) of article five (5) of the Constitution of the State of Nebraska be amended to read as follows:

Section 1. The executive department shall consist of a governor, lieutenant-governor, secretary of state, auditor of public accounts, treasurer, superintendent of public instruction, attorney-general, commissioner of public lands and buildings, and three railroad commissioners, each of whom, except the said railroad commissioners, shall hold his office for a term of two years, from the first Thursday after the first Tuesday in January, after his election, and until his successor is elected and qualified. Each railroad commissioner shall hold his office for a term of three years, beginning on the first Thursday after the first Tuesday in January after his election, and until his successor is elected and qualified; Provided, however, That at the first general election held after the adoption of this amendment there shall be alected three railroad commissioners, one for the period of one year, one for the period of two years, and one for the period of three years. The governor, secretary of state, suditor of public accounts, and treasurer shall reside at the capital during their term of office, they shall keep the public records, books and papers there and shall perform such duties as may be required by law.

All funds belonging to the state for educational purposes, the interest and income whereof only are to be used, shall be deemed trust funds held by the state, and the state shall supply all losses thereof that may in any manner accrue, so that the same shall remain forever inviolate and undiminished, and shall not be insected or loaned except on United States or state securities, or registered county bonds or registered school district honds of this state, and such funds, with the interest and income thereof are hereby solemnly pledged for the purposes for which they are granted and set apart, and shall not be transferred to any other fund for other uses:

Provided, The board created by section of this article is empowered to sell from time to time any of the securities belonging to the permanent school fund and invest the proceeds arising therefrom in any of the securities enumerated in this section bearing a higher rate of interest, whenever an opjortunity for better investment is presented;

A joint resolution proposing to amend section two (2) of article fourteen (14) of the Constitution of the State of Nebraska, relative to donations to works of internal improvement and manufactories.

Be it resolved and enacted by the Legislature of the State of Nebraska:
Section I. That section two (2) of article fourteen (14) of the Constitution of the State of Nebraska, be amended to read as follows:
Sec. 2. No city, county, town, precinct, municipality, or other subdivision of the

state, shall ever make donations to any works of internal improvement, or manufactory, unless a proposition so to do snall have been first submitted to the qualified electors and ratified by a two-thirds vote at an election by authority of law; Provided, That such donations of such subdivisions in the aggregate shall not exceed ten per cent of the assessed valuation of such county; Provided further, That any sity or county may, by a three-fourthat vote, increase such indebtedness five per cent, in addition to such ten per cent and no bonds or evidences of indebtedness so issued snall be valid unless the same shall have endorsed thereon a certificate signed by the secretary and auditor of state, shewing that the same is issued pursuant to law.




