PROPOSED CONSTITUTIONAL **AMENDMENTS**

The following proposed amendments to the Constitution of the State of Nebraska, as hereinafter set forth in full, are submitted to the electors of the State of Nebraaks, to be voted upon at the general election to be held Tuesday, November ? D., 1896:

A joint res amend sections t. .. four (4), and five (5,) of article six (6) of the Constitution of the State of Nebraska, relating to number of judges of the supreme court and their term of office.

court and their term of office.

Be it resolved and enacted by the Legislature of the State of Nebraska:
Section 1. That section two (2) of article six (6) of the Constitution of the State of Nebraska he amended so as to read as follows:

Section 2. The supreme court shall until otherwise provided by law, consist of five (5) judges, a majority of whom shall be necessary to form a quorum or to pronounce a decision. It shall have original jurisdiction in cases relating to reveaue, civil cases in which the state shall be a party, mandamus, quo warranto, habeas corpus, and such appellate jurisdiction, as may be provided by law.

Section 2. That section four (4) of article six (6) of the Contsitution of the State of Nebraska, be amended so as to read as follows:

six (6) of the Contsitution of the State of Nebraska, be amended so as to read as follows:

Section 4. The judges of the supreme court shall be elected by the electors of the state at large, and their term of office, except as hereinafter provided, shall be for a period of not less than five (5) years as the legislature may prescribe.

Section 5. That section five (5) of article six (6) of the Constitution of the State of Nebraska, be amended to read as follows: Section 5. At the first general election to be held in the year 1896, there shall be elected two (2) judges of the supreme court one of whom shall be elected for a term of two (2) years, one for the term of four (4) years, and at each general election thereafter, there shall be elected one judge of the supreme court whose terms have not expired at the time of helding the general election of 1895, shall continue to hold their office for the remainder of the term for which they were respectively commissioned.

A joint resolution proposing an amendment to section thirteen (13) of article six of the Constitution of the State of Nebraska, relating to compensation of supreme and district court

judges.

Section 1. That section thirteen (M) of article six (6) of the Constitution of the State of Nebraska be amended so as to read as follows:
Sec. 13 The judges of the supreme and district courts shall receive for tneir services such compensation as may be provided by law, payable quarterly.
The legislature shall at its first session after the adoption of this amendment, three-fifths of the members elected to each house concurring, establish their compensation. The compensation so established shall not be changed oftener than once in four years, and in no event unless two-thirds of the members elected to each house of the legislature concurrent.

A joint resolution proposing to amend section twenty-four (24) of article five (5) of the Constitution of the State of Nebraska, relating to compensation of the officers of the executive department.

other compensation that may be reafter be payable by law for services other compensation that may hereafter be payable by law for services performed by an officer provided for in this article shall be paid in advance into the state treasury. The legislature shall at its first session after the adaption of this amendment, three-fifths of the members elected to each house of the legislature concurring, establish the salaries of the oficers named in this article. The compensation so established shall not be changed oftener than once in four years said in 50 event unless two-thirds of the members elected to each house of the legislature cencur therein.

than once in every four years, increase
the number of judges of supreme and district courts, and the judicial districts of
the state. Such districts shall be formed
of compact territory, and bounded by
county lines; and such increase, or any
county lines; and such increase, or any
change in the houndaries of a district,
shall not vacate the office of any judge.

Frovided, however, That at the first general election held after the adoption of this amendment there shall be elected three railroad commissioners, one for the peried of one year, une for the period of two years, and come for the period of three years. The governor, secretary of state, auditor of public accounts, and treasurer shall reside at the capital during their term of office; they shall keep the public records, books and papers there and shall perform such duties as may be required by law.

Approved March 29, A. D. 1896
