Poor Little Thing.

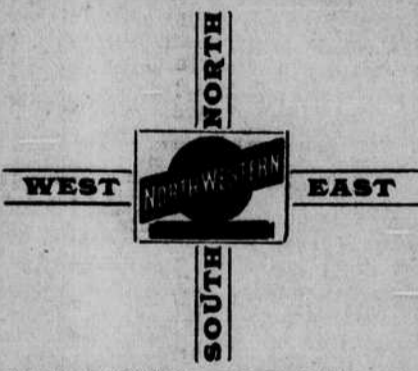
