



The man in the much-worn Broadway suit shrugged his shoulders. "Didn't you get the rifles bought of me?'


"Why, yes; my men have 1,200 Mausers now, thanks to you. But-'

"Yes, we got the cartridges and the two rapid ire guns that you brought to us, too, although where you got


"You gave me an order for 1,200 rifles and 300,000 rounds of cart: Iges. I delivered the goods. You say you got 'em. What's the kick?'
