

An ordinance providing rules and reg-ulations for the use of vehicles upon the streets and alleys of the city of O'Neill, Nebraska, and providing regulations for the standing or parking of vehicles upon such streets and alleys and providing penalties for violations of any of the pro-visions of this ordinance. Be it ordained by the Mayor and City Council of the City of O'Neill,

Nebraska. Section 1. It shall be unlawful for any person or corporation to move, transport, haul, drive, convey, permi transport, haul, drive, convey, permit to stand or otherwise move any vehicle upon, along or across any roadway within the corporate limits of the city of O'Neill, Nebraska, contrary to or
