



Contest starts, May 20th, and closes June 4th, 1939.

- 1st-Every contestant must be of legal driving age.
- 2nd—No employee of Chevrolet Motor Division or any of its dealers are eligible to compete.
- 3rd-Every contestant must have his drivers license with him and present it.

- 8th—The contestant may drive the car in any manner he chooses as long as the foregoing rules are observed.
