

Firsts


T was 1864. George B. Armstrong

of the U.S. Mail Service, with visions of a 'postal car" before him, discussed his plan with officials of the "North Western." These far-seeing men saw its possibilities, and on August 28th, 81 years ago, a rebuilt baggage car made the initial "post office" run between Chicago and Clinton, Iowa.

The postal car quickly proved its value. Three years later "North Western" designed five cars for railway post office service, the first in America built expressly for this purpose.




