



Sponsored by Holt physicians and extension clubs, the chest X-ray survey has as its goal the filming of every adult chest in the county. While youngsters under 12 years are remarkably free from pathological chest conditions, local physicians empha-

sized, they, too, are welcome, es-pecially if any symptoms exist. More than 507,000 Nebraskans have taken advantage of the Xray unit to receive their free chest X-ray, and 97 out of each 100

were found to be perfectly nor-mal and healthy.

The X-rays are taken mere-ly for screening purposes, and where any pathological condi-tion is found to exist, the individuals are referred to their personal physicians for further observation.

Following completion of X-raying in Stuart on Thursday, December 20, the unit will give chest X-raying in the following Holt communities:°
