State Capitol News

Budgets Sent Back for Down Revisions

LINCOLN — The enormity of the task facing the 1957 legislature becomes more apparent each time a state agency makes its request for tax money.

Budget hearings before Gov. Victor Anderson have been under way more than a week and the order of the day is requests for more money from taxpayers.

"We just can't raise taxes as much as these budgets coming in," the governor said.

Illustrating the problems more graphically, the state's chief executive said: "We are going to eliminate the frosting and get down to eating hardtack."

The governor made a series of statements concerning budgets during hearings. They included:

—The cost of operating the State Orthopedic hospital in Lincoln is getting too high for the patient load. The problem may have reached the point where it may become necessary to close the hospital and contact elsewhere for patient care.

—There may need to be increases in tuition fees for out-of-state students attending either of the four state-supported teachers colleges or the University of Nebraska.

—The board of control should study ways of making full use of the State Tubercular hospital at Kearney.

Regarding the Orthopedic hospital, the governor said the last patient count by the board of control showed 59 at the institution and 122 employees with a two-year budget of some \$590,000. "That's too expensive," the governor said.

But Dr. F. A. Alcorn, hospital superintendent, disputed the governor's figures. He said the patient load is nearer 4,500 per year including out patients and service to other state institutions.

On the matter of the higher educational institutions, together the University of Nebraska and the four teachers colleges — at Wayne, Chadron, Peru and Kearney—have asked for some \$7 million more in tax money.

"If this expansion is for out-of-state students," the governor said, "I'm going to look to my taxpayers."

Anderson has emphasized that "no one is for higher education more than I am. But it's a question of the ability of the taxpayer to pay."

At the same time, he says, he realizes the need for the institutions.

"It's a matter of a crisis at both ends," he commented.

At the Kearney TB hospital, the governor said the hospital capacity is 250 and when he visited it was nowhere near that total. The patient load has been declining yearly, he said.

The board of control, the governor said, should see if it can't find some other use for it.

The board said, meanwhile, it has been negotiating with Wyoming to care for patients from that state, as means of fully utilizing the hospital.

Dredla To Quit—Thomas Dredla, controversial chairman of the board of control, says he is not going to seek reappointment to the board when his term ends in June of next year.
