

ATOMS FOR POWER: Nebraskans, continuing

to use increasing amounts of electricity in the home, in business and industry, and on the farm, must have an additional source of supply by 1960-a supply over and above that furnished by the plants now being built or planned in the state. Consumers' new 100,000 kilowatt plant at Hallam will be a big factor in meeting these needs-first with conventional facilities to be completed in 1960, then with the nuclear reactor facilities scheduled for completion in 1961. With Atomic Energy Commission participation, the cost of this power to Consumers' customers will be in line with that produced by conventional generators.

ATOMS FOR PAYROLLS: Scores of applica-

tions-in food processing, in many types of manufacturing, in agriculture, in medicine, in research and education-are now being made with the radio-active by-products of nuclear reactor power generation. It is certain that industries wanting to use these by-products will be looking for plant sites and other com-mercial opportunities in Nebraska during and after the construction of the Hallam plant, directly contributing to greater industrialization in the state.

ATOMS FOR PEACE and PROGRESS:

The increasing use of the atom for constructive purposes will continue to help the United States to remain strong, and will make important contributions to world peace and progress. Nebraska, as the site of a nuclear reactor power plant, will have a major role in this program, and will become a center of world-wide atomic research.
