# **Burial at Butte** for 'Montana Jack'

Funeral services for John W. ("Montana Jack") Sullivan, 81, of Butte, Mont., who gained renown in professional circles from coastto-coast as a young man, were held at 9:30 a.m., Tuesday, October 28, at a requiem mass at St. Patrick's Catholic church Butte, Mont., with Rt. Rev. M. M. English, officiating.

Pallbearers were Paul Cannon, Tom Ryan, Al Brown, Ross McGinnis, Fred Green and John Harrington. A rosary was said at 8 p.m. Monday, October 27.

The late Mr. Sullivan, who was born in April, 1877, in Houghton. Mich., moved as a child to O'Neill with his parents. His parents were among the first homesteaders. He was reared and learned electricity here. This trade later led him to become the city electrician of Butte under two mayors, in addition to operating the old Sullivan Electric company in Butte for many years.

In 1895 he went to Anaconda with the late Judge J. V. Dwyer, onetime Butte district judge. He joined a brother, the late Phillip Sullivan. and "Montana Jack" became a professional boxer.


