#### TB Hospital

Nebraska cannot yet afford to close its tuberculosis hospital at Kearney. That's the opinion of Dr. E. A. Rogers, state health director. The hospital is under supervision of the State Board of Control. Rogers said TB cases and deaths have dropped but the hospital still answers a "very definite health need."

Hospitals over the state, Rogers says, are not geared to handle patients with tuberculosis. If the Kearney hospital were closed, an infected patient could remain at home and spread the disease, he added. Rogers revealed the state has under consideration an inten-

sive tuberculosis treatment pro-

gram designed to eventully stamp

Nursing Board A committee of state senators has recommended the State Board of Nursing remain as a separate department. The committee, headed by Sen. Otto Liebers of Lincoln, locked into functioning of the board as a separate agency, The question was whether the board might be put under the State Department of Health.

About five years ago the Legislature, because of the growth of the nursing profession, made the board a separate department removing it from the State Department of Education.

#### Otto Named

State Sen. Norman Otto of Kearney is busy at his new jobadministrative assistant to Gov-ernor-elect F. Morrison doesn't take office until January. Otto is working out of an office in n downtown Lincoln hotel as Morrison prepares for his administration. He has been a state senator since 1955 and previously had been a school superintendent, contractor and farmer.

Otto will work not only as Morrison's top aide, but as a liaison between the new governor and the Legislature, which will be predominantly Republican in makeup, although senators are elected on non-political tickets. The Kearney man was a well liked member of the Legislature where he was con-sidered to have a good sense of humor and to be a hard work-

Otto was defeated in a bid for lieutenant governor in the May 1 primary by Edward A. Dosek of Lincoln who later withdrew and Otto was appointed to run in the general election. In the Nov. 8 general election, Otto was beaten by Republican Gov. Dwight Burney who was re-elected to another term as lieutenant governor in

# Support and Endorse the School Board's Plan for a New O'Neill Public High School

### Important Facts on the O'Neill School Bond Election:

- 1. What is the amount of the proposed Bond Issue? The amount is \$465,000.
- 2. What tax levy will be necessary to pay for this Bond Issue?

Based on the 1960 School District assessed valuation of \$4,727,332.00, it will require an approximate annual tax levy of 7.25 mills to pay for this bond issue over a 20 year period.

3. Is this a good time to issue bonds?

The financial consultant for our district has advised us that the 71/4 mill levy is on the high side and that interest costs are more favorable now than at any time during the past several months.

4. What is FREE HIGH SCHOOL TUITION?

Students who live in another school district but attend the O'-Neill school must pay tuition to the School District of the City of O'Neill. The tuition money paid to O'Neill comes from a county levy on all property NOT in a high school district.

5. How much does the O'Neill School District receive in "Free **High School Tuition**"?

In the 1959-60 school year, the O'Neill school district received \$34,000 in tuition money.

6. If the O'Neill school district did not receive this tuition money, what levy would be necessary to raise this lost revenue now used to operate our school?

It would require a 71/4 mill levy to replace this revenue loss of \$34,000.

7. If we do not provide a complete curriculum for all students and the proper facilities, do we stand to lose the free high school tuition students? When?

Yes. Students not living in the O'Neill School District (No. 7) will have to go to school elsewhere starting in 1964.

## 8. How much would 7¼ mills for the bond tax levy cost me?

9. In other words, we in the O'Neill School District are going to pay 7¼ mills one way or the other-either for a new building or to replace lost revenue from free high school tuition students.

Yes. And the loss of these students and their families will have an impact on the City of O'Neill financially as a trade and service community.

10. How does our 1959-60 school mill levy compare with other districts in our area?
