#### **Civil Defense Course to Begin** Wednesday

All residents of O'Neill and the surrounding community are encouraged to enroll in a Civil Defense course being offered. The survival preparedness course will consist of four classes taught by local school instructors who have received special instructor train-

The first class will begin at 6:30 p.m. on Wednesday eve-ning, Mar. 27, and will be held in the O'Neill Public School. The three remaining classes will be held on consecutive Wednesday evenings, Apr. 3, 10 and 17. Each class will be about 3 hours in length. A coffee break will be provided by the O'Neill Chamber of Commerce. The O'Neill class will cover

the following subjects: the im-portance of family planning, duties of our government units in a disaster, what to do in case of a disaster, how to build a shelter in your basement, how to stock a shelter, our warning systems, and how to decontaminate yourself and your family. Children who have been examined at previous clinics are welcome to return so that their progress can be noted. A noon luncheon will be provided free for parents and children who may find it necessary to remain over the


