The stamping ground of the modern statesman, Ohio, is just now warning up for another election, and the politicians—from the dispatches—have not yet decided just what the harvest shall be; whether it will be whisky straight or whisky mixed with a slight tax.

When this campaign comes on red hot, it will be in order for the fanatical temperance party of that state to ascertain as speedily as possible, which party holds the advanced views on the question of restraining the evil, and then help the other party into power, because the one in advance does not come clear up to the prohibition standard. There is a beautiful logic about this manner of reforming the world which only the modern prohibitionist can understand and appreciate.

The inspections of the rail ways of the country to avoid all reasonable restraint by legislation or otherwise is daily evidenced by the disposition to contest every attempt at restraining them within what the people consider reasonable grounds, as well be noticed by the following announcement through the associated press dispatches. The C. B. & Q. have carried the Illinois law before the U. S. Supreme Court, where that corporation not only hopes to avoid the operations of the state law but seeks further warrant to crack its great whip omnipotently over the leased lines of that great corporation:

WASHINGTON, D. C., March 12.—The case of the Chicago, Burlington & Quincy road is still in argument in the United States Supreme Court, Mr. Bartlett, of Boston, today following Wirt Dexter in support of the road. If the company wins this case it will enable it to practically determine its own rates of fare, not only upon the main system of the Chicago, Burlington & Quincy road, but upon all the lines which have been consolidated with it. That, at least, is the claim of the lawyers, who say that, under the Illinois law, the parent company can extend to all the lines which have been consolidated with it whatever rights and franchises it may have. The gist of the pending case is the claim of the company to demand a higher rate of fare, by reason of a special statute, that is permitted by the general laws of Illinois.

The little morning talk of Mr. Gould, over a year ago, to the St. Louis board of trade, when he said, in substance, that his consuming desire to swallow all the railways of the country, and absorb all the telegraph stocks, had become merely a matter of amusement and pastime to him, was an alarming statement—made by one of the autocrats of our commercial world, to the producer of the great northwest;—the statement of a fact, which the producer had realized and felt before, viz., that owing to the ability of one or two men to own and control the railway and telegraph lines of this country, the products of the great northwest, were virtually at the mercy of their whims to fix arbitrary and exorbitant rates—destructive, almost, of all market values; a danger which the laws of trade, as often applied, could not avert, competition being practically abolished.

The great question has been, and will be, until a satisfactory solution is arrived at—how can this be remedied? In the case of our telegraph monopoly, a remedy has been suggested, and very favorably received and commented upon; and that is, that the government shall construct and maintain a telegraph system of its own, and gradually assume, by purchase, the franchises now owned by the wealthy few. We can see much in this proposed solution that recommends itself as a remedy. It would take the telegraph stock off the market, and this would stop the tendency and practice of arbitrarily raising the tariff rates, and thus taxing the customer and patron (who, in the regular course of trade, is compelled to patronize) to meet the losses sustained by the individuals owning the stocks and line—in gambling speculations in stocks which have proved disastrous; all the government would want would be a reasonable rate sufficient to maintain the lines in good repair and make the system a self-sustaining one.

Every individual and corporation would be placed upon an equal footing, and no one class could monopolize these great agencies of trade and intelligence, to the exclusion of its competitor and neighbor.

City Assessment.

There is justly a great deal of criticism over the last year's assessment of property in Plattsmouth city for revenue purposes.

The city has an assessor for each one of its four wards, and by taking their valuation for the year 1882, as shown by the assessment rolls or lists, the inequality of valuations is very manifest; for instance, the real estate valuation of the 4th ward was only about \$10,000 greater than the realty valuation for the 3d ward, although all the business portion of the city on the south side of Main street and all the B. & M. R. R. interests lie in that ward.

Of course our city board of assessors cannot in the listing and valuation of property afford to place one ward higher than that placed upon another property throughout the city.
