Civil Service Commissioner's Conference.

CIVIL SERVICE COMMISSION.
WASHINGTON, March 11.—Members of the civil service commission called at executive mansion and had a short conference with the president in regard to the general plan of operations to be observed in carrying the law into effect. It was agreed that the commission should prepare a set of rules in regard to questions under their jurisdiction and submit them to the president for approval. Selection of chief examiner under the commission was not agreed upon.

PRESIDENT OF THE SENATE.
It is understood that Senator Edmunds will only retain the office of president of the senate until next December, when he will give way to Senator Anthony. Edmunds left last Friday for Aiken, S. C. He has gone to join his family, who spent the winter there. Edmunds proposes to go to New Orleans with his family for a visit, from there to go to the Pacific coast. He will probably remain with his family in California the greater part of the summer. This trip is made solely on account of the frail health of his surviving daughter.

THE NEW NICKEL.
The secretary of the treasury having directed that the word "cents" be added to the new 5 cent piece, the superintendent of the Philadelphia mint is engaged in preparing a device for the back of the proposed coin. No order, however, has been made suspending coinage of the new nickel, and the mint bureau report their issue at the rate of nearly \$3,000 a day, an amount sufficient to supply about all the demand. The French government has adopted nickel coinage instead of bronze.

SUIT FOR DAMAGES.
Thomas Worthington, of Ohio, today filed suit against E. W. Keightley, third auditor of the treasury, for \$50,000 damages, on what are described as "one hundred false, malicious, libellous and groundless allegations calculated and intended to prevent payment by the United States of the plaintiff's just claims for army supplies furnished volunteer troops at Camp Denison, Ohio, in 1861." The complaint sets forth that the allegations referred to were made by the third auditor in various official reports.

Death of Gortschakoff.

A Plot to Murder the Czar.

BADEN BADEN, March 11.—Prince Gortschakoff, ex-collector of the Russian empire, is dead.
ATHENS, March 11.—The chamber of deputies adjourned until the 16th inst., out of respect to the memory of the late M. Coumoundouroc, ex-prime minister. A public funeral is proposed.
ST. PETERSBURG, March 11.—It is stated the police were warned from Paris of a plot to murder the Czar. A lady was arrested at Charkov. A key was found on her cipher documents which had been previously seized.
ROME, March 11.—Two ladies, the last descendants of Amerigo Vesputius who gave the name of America to the Western Hemisphere, are now begging that a pension of ten crowns per month, which was assigned to their family by the republic of Florence in 1690, be restored.

CHICAGO, March 10.—A cremation society, with a capital of \$100,000 is to be formed here at once.

BOSTON, March 11.—Mr. Eben Tourgee, who sixteen years ago founded the New England Conservatory of Music, now the largest music school in the world, has presented the institution to a board of trustees, who accepted the gift in behalf of the city and will take possession as soon as the necessary legal forms are complied with.
