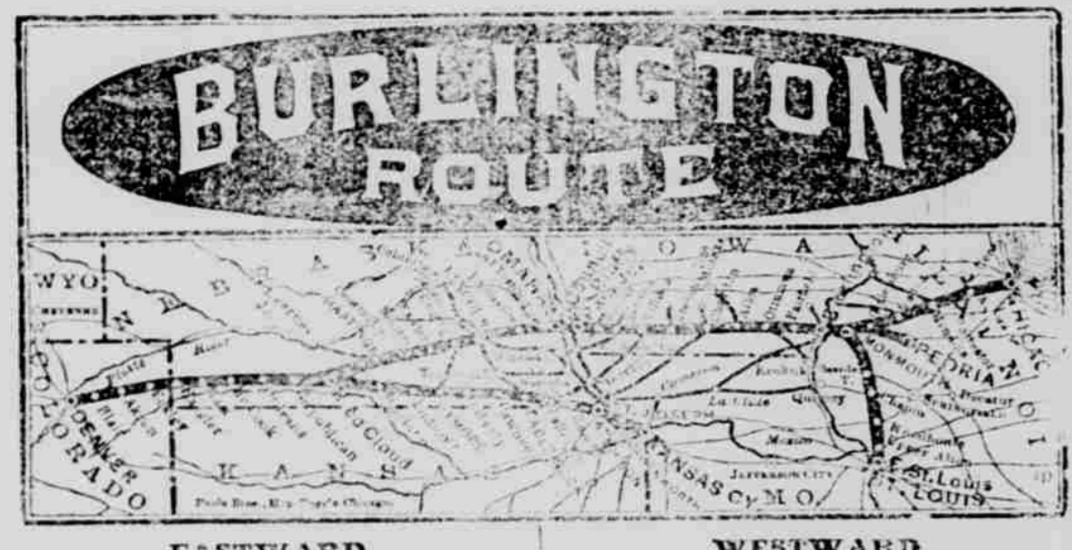

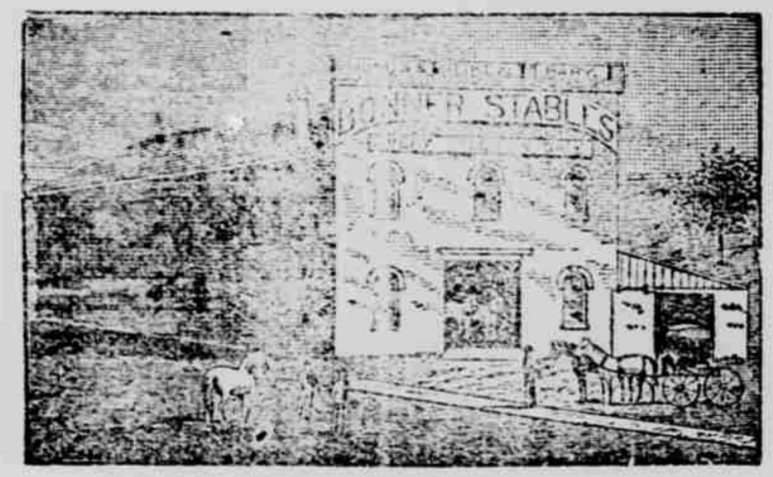

M. Hatt, for regent of the state university.
