



Educating the Chinese,

The Chinese government, under the liberalizing influence of the new regime of the young emperor, has adopted a curious and significant scheme of geiting at the bottom facts about civilization outside the flowery empire. A dozen distinguished young scholars will be selected from competitive examination, in which the chief test will be ability to describe and apprehend the meaning of novel things, and they will be sent abroad for two years to study foreign countries. Each will get a salary of \$250 a month and \$50 for an interpreter, and all their traveling expenses. Each will follow a particular bent in working up things he knows the most about. Monthly reports on topography, ethnology, commerce, habits, morality, industries, armaments, political institutions, etc., will be forwarded to Pekin. At the end of two years the services of each will be utilized in the Chinese government in such departments as he studied to the most advantage, and those who have done best will get ennobled. When one considers some of the raw, untutored and indifferent officials that America sends abroad, there rises just a scintilla of doubt whether the Occident really monopolizes all the civilization of the world .- Chicago
