because we happen to be nearer

to her. We must offer proper in-

ducements if we want her patron-

age. She has a right to ask that

we make reasonable concessions to

her and duplicate the favora ex-

tended to her by our rivals. We

are prepared to furnish her with

practically everything that she im-

ports, and to take practically every-

thing that she exports; but this

counts for nothing unless we make

it to her interest to do all of her

trading with us. She is perfectly

willing to buy more from us if we

will so arrange things that she can

proper care of our own interests.


