### Decision Favors Morgan.

(From Monday's Daily) A decision was rendered today by Judge Archer in favor of Mrs. Morgan in the Morgan vs. Murphy case spoken of in last Saturday's News. It is a rather unusual case where the wife's property is now held liable for the sum of \$69, the value of household necessities in the form of clothing purchased from the Morgan store a few years ago. A judgment was secured against Mr. Murphy last year but not having possessions valued to that amount, the sum was never obtained by the plaintiff. Today's decision would cause the claim to be paid out of the wife's possessions, but it will probably be carried up to a higher court and it will be some time yet before the case is settled.

### District Court in Session.

The district court is in session today and a number of the much talked of cases will be brought up this afternoon. Arthur Brann, the young fellow held for stealing horses and Harrison and Lynch, the two men accused of breaking the store at Weeping Water, will be brought up for trial late this afternoon. The application of Henry Zuckewiler to sell real estate belonging to the minor heirs of the George Lutz estate will be presented to the court.

### Escaped Prisoner Caught.

John Miller, the young fellow that was arrested last week on the charge of being drunk and conducting himself in a vicious manner, escaped from the hand of the law while working out his fine on the streets Saturday night. Miller has a reputation for pulling off that little stunt, but he didn't succeed in getting out of the city this time. He was located by the police and caught about one o'clock Sunday afternoon at Smith's livery barn. He was placed at his work again this morning, but a little better watch will be kept of him in the future.
