

TAKE ACTION ON SEVERAL PE-TIONS IN REGARD TO ES-TABLISHING ROADS

Pass Resolution Providing for the Equipping of Home Guard Companies in County

Plattsmouth, Neb., May 7, 1918. Board met pursuant to adjournment, Present Julius A. Pitz, C. E. Heebner and Henry Snoke, County Commissioners and Frank J. Libershal, County Clerk. Minutes of previous session read and approved, when the following business was transacted in regular form:
