PIONEER WOMAN OF THE MID-WEST

Mrs. Isaac McBroom, Aunt of J. M. Young of this City, a Pioneer Resident of Mills Co.

The following, taken from the Glenwood Tribune, will be of interest to many of the old residents of Cass county...

"Some pioneers of Glenwood will recall Mr. and Mrs. Isaac McBroom, who were residents of this vicinity from 1854, the date of their marriage in Glenwood, until 1860, when they moved to Colorado.

"A Denver paper tells in detail of the life of the pioneers, shows a picture of Mrs. McBroom and also a picture of the log cabin in which she lived many years.

"Mrs. McBroom resided in Colorado nearly sixty years on the same ranch in the north of the Creek canon, twenty miles distant from Denver.

"Mrs. McBroom came to Colorado in the spring of 1850, in a prairie schooner driven across the plains by her husband and drawn by oxen.

"Immediately upon arriving in Denver McBroom made preparations to homestead a piece of land near what is now Fort Logan.

"The McBroom's first home was a cabin built of cottonwood logs, 'chinked' with adobe. The chimney at one end of the structure was constructed of adobe; and so substantial was the building that it stands to this day.

"Several years after their arrival McBroom built a then up-to-date house of brick. For more than forty years, Mrs. McBroom lived in this house. She always declared that she would die there.

"The McBroom claim was the second in Colorado to be proved up. In those days ranchers worked with their irrigating shovels in one hand and their rifles in the other.

"The old cabin was built by McBroom and his younger brother, John McBroom, and for years was a sort of half-way house for the famish trappers and settlers of the north.

"Mrs. McBroom is survived by a daughter, Mrs. Clark Payton, of Fort Logan.
