



which may be created by law and not otherwise by law or herein provided for, and no such officer shall

be appointed or elected by the legis lature.'

In reply the attorney genera said: "This requirement of sub mission to the senate alone supplie to executive appointments already provided for by the constitution such as tax commissioners, and all ap pointments to executive positions which may hereafter be created by the election of the officers of the law.
