### NO CHANGE IN THE ROMAN CATHOLIC SEE

Death of Cardinal Gibbons Not to Have that Effect. It is Announced in Baltimore.

Baltimore, March 25.—The death of Cardinal Gibbons will not precipitate the removal of the primatial see of the Catholic church in America. This was definitely announced last night by Rev. Albert E. Smith, secretary of the late cardinal. The seat of the hierarchy will remain in Baltimore. As the appointment of a successor the archbishopric here involves no issue or question of rank or seniority, any clergyman in the hierarchy dominion becomes eligible.

A selection will be made by Pope Benedict. In the meantime an administrator will serve. Bishop Owen B. Corrigan will probably be named to this post by the diocesan consultors, who meet at the cardinal's residence tomorrow.

In view of the fact that there are two American cardinals, prominent Baltimore Catholics said today they did not anticipate the creation of a new cardinal for Baltimore to succeed Cardinal Gibbons, who died yesterday.

According to the usual procedure, the bishops of the Baltimore province will meet in secret conclave within two months to select three names for recommendation to the pope for appointment as archbishop of Baltimore. The cardinal's throne in the cathedral will be divested of its brilliant red hangings which will be replaced by deep purple in anticipation of the coming of a new archbishop.

The new archbishop will, it is understood, be one of the three bishops recommended to the pope, although he is not required to choose one of them.

Among the prominent ecclesiastics mentioned are Bishop William T. Russell of Charleston; Bishop Michael J. Curley of St. Augustine and Bishop Thomas J. Shan, rector of the Catholic university.

Preparations for the funeral next Thursday of Cardinal Gibbons were approaching completion at the archiepiscopal residence today. Meanwhile the body of the prelate will remain in the chamber where he died yesterday, until next Sunday evening when it will be taken to the cathedral and there lie in state until it is removed to its resting place in the crypt under the chancel after the final services.

Monsignor Bonzano, apostolic delegate at Washington, has been chosen to pontificate at the solemn requiem mass on Thursday and Archbishop J. J. Glennon of St. Louis, who delivered the sermon at Cardinal Gibbons' golden jubilee here in 1911, will also preach the funeral sermon.
