SMALL TOWNS BREED BIG MEN, SAYS HOWE

"Small Things of Life Are Your Big Things,"—Praises Middlewest Country in Speech. Falls City, Neb., Oct. 2.—"Out of your country towns come your big men of the country," Ed W. Howe, the sage of Potato Hill, at Atchison, told the Rotary club here today. "The small things of life are your big things," he added. These are the things that really count. They are living in the smallest part of the world. It is the richest section of the world, especially the region from Nebraska City south about 100 miles. I have traveled over the world and I know." Alluding to salient features that marked his graduate rise in the literary world, Mr. Howe referred to his two trips around the world, incidentally mentioning his first experience in being featured by a New York paper. It was on the occasion of a paper in reporting the address, dwelt at length on the fact that his stories were the most original ever heard in New York. "And Ed Stoughton told me those stories in Falls City nearly 50 years ago," he said. "Which shows there is nothing really original."
