Why worry about it? Why be unhappy over it? Why make the slightest fuss over our own personal experience of all the children of men?

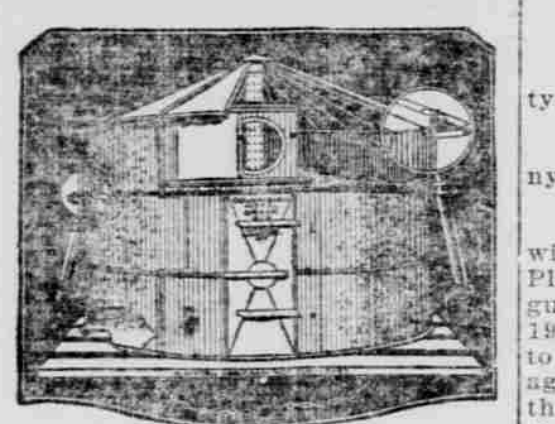
Why not be cheerful about it? If you are sincerely religious, you ought to be glad to grow old.
