Court Holds Mrs. Inas Wever for Trial Jan. 19th

Evidence Against the Defendant in Preliminary

On Wednesday afternoon Judge A. H. Duxbury in the county court held Mrs. Inas Wever for trial in the district court on the charge of first degree murder, she being charged with the death of her husband. George E. Wever, who died here on December 9th and whose passing was investigated by County Attorney W. Kieck, Sheriff Bert Reed and State Sheriff W. C. Condit with the result that information charging first degree murder was preferred against her in the court.
